Terms and Conditions

The Promoter of the Win A Car Competition is Autopact Victoria Pty Ltd (ABN 42 618 771 574) Trading as Bayford Ford and Bayford Volkswagen

Conditions of Entry:

*Entry instructions and prize information form part of these Conditions of Entry. By participating, entrants agree to be bound by these Conditions of Entry.

One entry into the competition will be granted upon the purchase of a new or used vehicle during the competition period from the following Bayford Dealerships:

The entry will only become valid and placed in the draw if the vehicle is delivered to the purchaser by 5.00pm on June 30th 2019. Customers who have ordered vehicles but have not been delivered by that date will not be eligible.

*A second entry will be granted to those purchasers who fulfil the vehicle delivery clause by June 30th 2019, and finance the purchase of the vehicle through the Bayford Ford or Volkswagen Finance Department at the dealership of purchase.

A maximum of two entries into the Win A Car Competition are available to purchasers.

Prize Pool: The prize for the Win A Car Promotion is a 2019 Ford Focus Hatch OR a 2019 Volkswagen Golf vehicle including on road costs and dealer delivery charges.

The total prize pool is valued at a minimum of \$25,990.
